- (3) a person born outside The Bahamas to a Bahamian father who is a citizen of The Bahamas by virtue of Article 3 or 8 and who is married his non-Bahamian mother.

An applicant applying for a Resident Belonger Permit is required to submit with this application the following:

- (a) Covering letter to the Director of Immigration
- (b) Cover letter from the parent or legal guardian to the Director of Immigration (Minor)
- (c) Certified copy of applicant's birth certificate
- (d) Immunization Card
- (e) Police certificate
- (f) Two (2) passport size photographs
- (g) Copy of applicant's national passport
- (h) Certified copies Parent's birth certificates
- (i) Documentary evidence of parent's Immigration status
- (j) Copies of parent's passports
- (k) Certified copy of marriage certificates (where applicable)
- (l) Death certificates where in either case the parents are deceased
- (m) Copy of National Insurance card, if any
